Personal data that we process

Smart Commute BV processes your personal data because you are or have been making use of our services and / or because you have provided this data to us. Below you will find an overview of the personal data we process:

- Information about your activities on our website
- Internet browser and device type

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data from website visitors under the age of 16, unless they have permission from parents or guardians. However, as we cannot check whether a visitor is older than 16 we advise parents to be involved in the online activities of their children to prevent data being collected without parental consent. The purpose and basis on which we process personal data

Smart Commute BV processes your personal data for the following purposes:

- To deliver goods and services to you

- Smart Commute BV analyses your behaviour on the website to improve the website and to adjust the range of products and services we offer to your preferences
- Smart Commute BV monitors your surfing behaviour on various websites for the purpose of tailoring our products and services to your needs
- Smart Commute BV also processes personal data if we are legally obliged to do so, such as data necessary for our tax returns

Automated decision making

Smart Commute BV does not allow decisions based on automated processing to be made about matters that can have (significant) consequences for people.

How long we keep personal data

Smart Commute BV does not store your personal data longer than is strictly necessary to realize the purpose for which your data are collected.

Sharing of personal data with third parties

Smart Commute BV does not sell your data to third parties and will only do so if necessary for the implementation of our agreement with you or to comply with a legal obligation. We work together with companies that process your data on our behalf and enter into a processor agreement with them to ensure the same level of security and confidentiality of your data. Smart Commute BV remains responsible for these processes.

Cookies, or similar techniques, that we use

Smart Commute BV uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Smart Commute BV uses cookies with purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to optimize it. In addition, we place cookies that track your surfing behaviour so that we can offer customized content and advertisements. On your first visit to our website, we have already informed you about these cookies and have requested your permission to place them. If you so wish you can delete all information that was previously saved via the settings of your browser. Cookies are also placed on this website by third parties.
